DE PERE –Two members of De Pere Fire Rescue were chosen as recipients of this year's Wisconsin First Responder of the Year Awards. The two were presented with their awards Oct. 26 in Madison at the State Capital.

Earning awards were Lt. Brett Jansen and Lt. Tom Nelson. They were nominated by Fire Chief Alan Matzke for their outstanding dedication.

Jansen has worked for De Pere Fire Rescue for 15 years. He was chosen by Representative Shae Sortwell (R-Two Rivers) of the 2nd Assembly District.

Lt. Tom Nelson has worked for De Pere Fire Rescue for 14 years. He was chosen by Representative John Macco (R-Ledgeview) of the 88th Assembly District.
