## COMMON COUNCIL MEETING CITY OF DE PERE, WISCONSIN - June 17, 2008

The Common Council of the City of De Pere, Wisconsin, met in regular session at the Council Chambers in City Hall, on Tuesday, June 17, 2008.

Mayor Walsh called the meeting to order at 7:36 pm. Roll call was taken and the following members were present: Alderpersons Carl Castelic, Michael Donovan, Bob Heuvelmans, Paul Kegel, Dan Robinson, Kathy Van Vonderen and Bob Wilmet. Alderperson James Boyd was excused. The Opening Prayer was given by Alderperson Donovan and followed by the Pledge of Allegiance to the Flag.

Alderperson Kegel moved, seconded by Alderperson Robinson, to approve the minutes of the June 3, 2008 Council meeting. Upon vote, motion carried unanimously.

## **PUBLIC HEARINGS**

4. A Public Hearing to act on rezoning Parcels WD-104 and WD-100-3 located at 500 and 506 Butler Street, petitioner LTF, LLC is scheduled for 7:35 p.m. The Notice of Public Hearing was published in the City's Official Newspaper, the De Pere Journal on May 29 & June 5, 2008. Planning Director Ken Pabich stated the Plan Commission recommended approval.

Mayor Walsh declared the public hearing open for anyone wishing to speak and there was no one present who wished to speak and the public hearing was closed.

Ordinance #08-13 Rezoning Certain Property (Parcels WD-104 and WD-100-3) was presented. Alderperson Van Vonderen moved, seconded by Alderperson Kegel, to enact the ordinance. Upon vote, the Ordinance was enacted on a unanimous vote.

5A. A Public Hearing to act on rezoning Parcels ED-808, ED-809, ED-810, ED-811 and ED-812, located at 222, 230 and 232 Wisconsin Street and 229 and 221 South Broadway, petitioner Medical Arts Complex Dental Center, S.C. is scheduled for 7:35 p.m. The Notice of Public Hearing was published in the City's Official Newspaper, the De Pere Journal on May 29 & June 5, 2008. Planning Director Ken Pabich stated the Plan Commission recommended approval.

Mayor Walsh declared the public hearing open for anyone wishing to speak and there was no one present who wished to speak and the public hearing was closed.

Ordinance #08-14 Rezoning Certain Property (Parcels ED-808, ED-809, ED-810, ED-811 and ED-812) was presented. Alderperson Donovan moved, seconded by Alderperson Robinson, to enact the ordinance. Upon discussion and vote, motion carried unanimously.

5B. A Public Hearing to act on rezoning Parcels ED-806, ED-807 and ED-814, located at 208, 212 and 205 S. Broadway, petitioner City of De Pere, is scheduled for 7:35 p.m. The Notice of Public Hearing was published in the City's Official Newspaper, the De Pere Journal on May 29 & June 5, 2008. Planning Director Ken Pabich stated the Plan Commission recommended approval.

Mayor Walsh declared the public hearing open for anyone wishing to speak and there was no one present who wished to speak and the public hearing was closed.

Ordinance #08-15 Rezoning Certain Property (Parcels ED-806, ED-807, and ED-814) was presented. Alderperson Wilmet moved, seconded by Alderperson Van Vonderen, to enact the ordinance. Upon discussion and vote, motion carried unanimously.

Resolution #08-62 Authorizing Redevelopment Agreement Between the City of De Pere, the Redevelopment Authority of the City of De Pere, and Medical Arts Complex Dental Center, S.C. was presented. Alderperson

Van Vonderen moved, seconded by Alderperson Castelic, to approve the resolution. Upon roll call vote, motion carried unanimously.

7. <u>Public Comment or other Announcements:</u> Alderperson Castelic announced the State Historical Society sent a letter to anyone living in a historic district notifying them there would be a presentation next week Tuesday, June 24 at City Hall to explain the tax credits and other things available for living in a historic district.

## RECOMMENDATIONS FROM THE LICENSE COMMITTEE

- 8A. Alderperson Heuvelmans moved, seconded by Alderperson Castelic, to approve an Application for a Class "B" Beer & "Class C" Wine License for Gyro Kabobs, 337 Main Ave., De Pere, submitted by Gyro Kabobs III, LLC. Upon vote, motion carried unanimously.
- 8B. Alderperson Castelic moved, seconded by Alderperson Heuvelmans, to approve an Application from Teekae Enterprises, Inc., of Wis. to change the trade name of Beer: 30, 132 Front Street to the Boiler Room and a change of agent from Jim Steiner to Nicolas Gallenberger, 2155 Sunnymede Lane, Green Bay for their July 1, 2008 to June 30, 2009 Class "B" Beer & "Class B" Liquor and Dance & Entertainment License. Upon vote, motion carried unanimously.
- 8C. Alderperson Wilmet moved, seconded by Alderperson Heuvelmans, to approve an Application for a Special Permit Allowing Consumption of Alcohol Beverages on Public Ways, submitted by the De Pere Area Chamber of Commerce for west side evening Farmer's Market.

Alderperson Kegel moved, seconded by Alderperson Robinson, to open the meeting. Upon vote, motion carried unanimously.

Cheryl Detrick, Executive Director for the De Pere Area Chamber of Commerce, responded to concerns about the presence of alcohol at the Farmer's Market stating they envision a family, friendly event and not a festival with loud music. They will be policing the area and the police department is also aware of the event. This is a brand new event so they are not sure how it will look. She stated they would keep an eye on the alcohol consumption.

Alderperson Van Vonderen moved, seconded by Alderperson Robinson, to return to close the meeting. Upon further discussion and vote, the special permit was approved with 5 ayes and 2 nays. Alderpersons Kegel and Robinson voted nay; all others voted aye.

## RECOMMENDATIONS FROM THE BOARD OF PUBLIC WORKS

- 9A. Alderperson Kegel moved, seconded by Alderperson Donovan, to award Project 08-07 Bituminous, Paving, Bituminous Overlay and Street Repairs to Northeast Asphalt, Inc. of Green Bay, WI in the amount of \$528,965.85. Upon roll call vote, motion carried unanimously.
- 9B. Alderperson Castelic moved, seconded by Alderperson Heuvelmans, to award Project E08-11, Two 2009 1-Ton 3500 HD Trucks with Dump Box to Monroe Truck Equipment of De Pere, WI in the amount of \$79,748. Upon roll call vote, motion carried unanimously.
- 9C. Alderperson Donovan moved, seconded by Alderperson Castelic, to award Project E08-12, One 2009 1-Ton 3500 HD Truck with Dump Box to Monroe Truck Equipment of De Pere, WI in the amount of \$42,140 with trade. Upon discussion and roll call vote, motion carried unanimously.
- 9D. Alderperson Kegel moved, seconded by Alderperson Van Von Vonderen, to award Project E08-13, One Six Wheel Regenerative Air Street Sweeper with Catch Basin Cleaner to Bruce Municipal Equipment, Inc of Menominee Falls, WI in the amount of \$192,680. Upon discussion and roll call vote, motion carried unanimously.

20. Resolution #08-50 Authorizing Street Improvements and Levying Special Assessments Against Benefited Property (Lawrence Drive from Scheuring Road to Main Avenue) was presented. Scott Thoresen, Public Works Director, went over the handout he provided showing three assessment options including 1) assessment based on front foot, 2) assessment based on front foot w/state frontage, and 3) assessment based on contribution to runoff. Discussion followed.

Alderperson Heuvelmans moved, seconded by Alderperson Van Vonderen, to open the meeting. Upon vote, motion carried unanimously.

David Kubiak, representing 765 Lawrence Dr, stated he already spent \$20,000 for a site plan and then he was informed they have a lot of runoff that he doesn't agree with. He suggested using a lineal foot price to be paid, which is the fairest way. Most of his water goes to 9<sup>th</sup> St and he doesn't think the proposed assessment is equitable.

Lee Schley, City Engineer, responded that all the assessments are based off of the contour maps and most of the properties on Lawrence Dr are split, with the front portion going to Lawrence Dr in the ditches and the back portion going to 9<sup>th</sup> St.

Randy Johnson, 939 Lawrence Dr, representing Cummins Great Lakes, addressed the Council indicating their lot in the back slopes to 9<sup>th</sup> St so why assess them for contribution of runoff since most of their runoff goes that way. Also, the City is going to move the new road, which he is in favor of, and will take 1 ½ lanes of their front yard so they will lose the additional green space. Ninety-nine percent of where the new road is being moved is grass that will be paved, which is additional run off they will be losing.

Lee Schley responded that many of the these properties are split down the middle and the portion that fronts Lawrence Dr flows to Lawrence Dr and the back portion will discharge to 9<sup>th</sup> St. He stated moving the road closer to the east side that was extremely wide right-of-way and they have not acquired any additional right-of-way to build this road. They still have about 10ft of terrace beyond the edge of curb and gutter, for instance, where sidewalk could be put in at some future date so it's appropriate to relocate it to where they are putting it.

Bill Gray, 939 Lawrence Dr, representing Cummins Npower, questioned the method of calculating how this is being done based upon future development. He asked if that was the way the park-n-ride was assessed also? Because they have vacant property and the park-n-ride is vacant property. Is the park-n-ride being considered for future development? It was mentioned if the city system going in now were combined with the state system going in a few years, the pipeline had to be three to four times the size to handle all of it. In previous conversations, it was noted there was only 6% of the state run off so how could 6% of the total runoff coming from the state force the city to quadruple the size of the pipeline if they went with one pipeline along with the state?

Lee Schley stated the formula to carry contribution for runoff is based on existing conditions not based on construction that will take place 4 years down the road. It is based on 3.8% of the land, the ditch, lanes of the road, and another 2% that is the park-n-ride and both added together equals 6%. When they saw the state plans for their design on the six lane road, the 2% for the park-n-ride remain and the other area would be reduced to 2% because there would only be the grass side slope that comes off the highway. The park-n-ride was figured at full development at a coefficient of .75 the same as any other commercial establishment along there. The contribution to runoff is only figured by the area that flows to the front of Lawrence Dr and nothing that goes to 9<sup>th</sup> St. or another direction.

Pat Byrne, 426 S. Huron, and representing property at 1216 Renkins Ct, stated a month ago this issue would have been passed if several parties had not shown up at that meeting to express their views on the assessment. He noted everyone is willing to pay their share but would like the council to consider the information put before them by Stuart Frankenthal and other property owners. He believes that is a fair assessment.

Russ Van Rite, 2060 Autumn Lee Circle, Ashwaubenon, spoke on behalf of Scheuring Mobil, stating the

question he has is most of the landowners are on the opposite side of the street from him. He noted they are supposedly being assessed 100% even though Walmart is on other side. If Walmart already paid their share, why would they have to be assessed 100% of the value when there is someone on the other side? Also, 90% of his water goes to the back of his lot, which has a retention pond already and goes to the creek and heads to the south not to Lawrence Dr.

Lee Schley, City Engineer stated his property is similar to the properties on the east side of the road where it is split for the contribution to Lawrence Dr. They did not include the property that flows to the back into the retention pond. When Walmart built, they were required to put in certain improvements and paid for it. This frontage is servicing the other side of the road.

Ron Aspenson, representing 1031 Lawrence Dr, and the largest assessment on the handout stated if the third assessment option is selected based on contribution to runoff he wanted to make sure they would be notified of the hearing. He feels \$151,000 is quite a bit and he wants to be sure he knows about the hearing. Stuart Frankenthal, Jass Realty Co., LLC and owner of 421 Lawrence, stated he is in a unique situation since his property was reduced by \$40,000. He felt the assessment they suggested four weeks ago is the correct appropriate method in place of the assessment based on front foot. It's a fair and reasonable methodology for everyone.

Alderperson Heuvelmans moved, seconded by Alderperson Van Vonderen, to close the meeting. Upon vote, motion carried unanimously.

Discussion followed. Alderperson Heuvelmans moved, seconded by Alderperson Kegel, to approve Option 2: Assessment based on front foot w/state frontage. Upon roll call vote, motion carried with unanimously.

- 10A. Alderperson VanVonderen moved, seconded by Alderperson Kegel, to approve the 2007 Audit Report. Upon vote, motion carried unanimously.
- 10B. Alderperson Donovan moved, seconded by Alderperson Castelic, to approve request to draft a letter to the WI Department of Administration asking to continue receiving the distribution of the lottery tax credit and the school tax credit. Upon vote, motion carried unanimously.
- 10C. Alderperson Wilmet moved, seconded by Alderperson Van Vonderen, to approve the 2008 Dental Renewal and Premiums. Upon roll call vote, motion carried unanimously.
- 10D. Alderperson Van Vonderen moved, seconded by Alderperson Castelic, to approve the 2008-2009 Insurance Liability Policy Renewals. Upon roll call vote, motion carried unanimously.
