

DE PERE MUNICIPAL COURT COMMUNITY SERVICE OPTIONS

1. You are responsible to contact a non-profit organization, perform your community service hours, and you are responsible to turn in your hours to the Court.
2. Service hours CANNOT be done for an individual or at a for profit business (example: shoveling a neighbor's sidewalk or mowing lawns for a yard care company, or a business.)
3. When you contact a service organization to set up hours, ask to speak to the volunteer or community service coordinator. **IT IS YOUR RESPONSIBILITY TO FOLLOW UP WITH THE VOLUNTEER ORGANIZATION TO SCHEDULE YOUR HOURS.**
4. Hours may be completed in more than one place.
5. Send in or bring in written proof from the organization of your completed community service hours.
6. Each hour of community service is = to \$10.00 of the forfeiture due.
7. You must complete your community service hours and/or pay the total forfeiture by the due date given to you in Court and you must turn in your hours to the Court by that deadline.
8. The court does not have a form to bring to the agency, most have their own forms or have them write a letter to the court with your hours and dates on it and have it signed by them.

**DO NOT PRESUME THE VOLUNTEER ORGANIZATION WILL SEND IN YOUR HOURS FOR YOU.
IT IS YOUR RESPONSIBILITY TO TURN INTO THE COURT ON TIME.**

The locations on this list may not accept you as a volunteer due to your offense, age or availability. You must follow the rules of the location supervisor. If you do not meet the site supervisor's requirements the hours may not count.
