This topic has been part of various discussions over the last two years during budget time. The City Council has asked us to have a discussion on the future of this funding. I have included a summary page in your packet. (See attached information)

### 5. <u>Discussion on Ice Arena Lease and funding a feasibility study for a second sheet of ice at the Ice Arena.</u>

As part of our effort to look at the Ice Arena Lease, a few points came up that we would like to get opinion and direction on from the Park Board. First, in order to appropriately research and analyze our lease options we feel that the City should extend the current lease with Ice Time Management for 18 months. I have briefly discussed this with Ice Time Management and they have preliminarily informed me they are ok with it. Second, as part of the investigation with our future lease, it is felt that the City should consider conducting a feasibility study on a second sheet of ice. I have sent a request to user groups to ask for their interest in participating in the study. I will inform you of our findings at the meeting.

Staff Recommendation: 1) Approve offering a lease extension of 18 months to Ice Time Management, forward to Legal Counsel. 2) Approve the conducting of a feasibility study for a second sheet of ice at the Ice Arena.

#### 6. Review and action on Teen Advisory application packet.

I have included a proposed application packet for our Teen Advisory positions. The program has been approved through City Council. Once the application packet is approved we will begin to advertise and work with local schools to market the program. (See attached info.)

Staff Recommendation: Approve

#### 7. Review and acceptance of donations over \$250.

The first donation is from De Pere Optimist Club of \$700 to the annual Easter Egg Event held at the Community Center. This donation goes to offset the costs of the special event to make it a free event to our community. The second donation is also from the De Pere Optimist Club for approximately \$800. This donation is to cover the costs of T-shirts for the Summer Day Camp.

Staff Recommendation: Approve (forward to Council)

## 8. Request funding for pool consultant and drain work at VFW and Legion Pools to have them meet standards set forth by the Virginia Graeme Baker (VGB) Act.

The VGB Act is requiring all pools to meet certain drain criteria. As part of the mandate we are being required to have a consultant conduct a flow analysis and then change our drain covers. Although the VGB Act has been in the works for a long time, we were not made aware of the mandated pool consultant costs until the last couple of months. Staff has been busy investigating and confirming mandates, and obtaining quotes. In talking with our Administrator, funding for this should come from City Contingency Funds. (See attached information)

Staff Recommendation: Approve and forward to Finance Committee.

#### 9. Review and consider acquisition of Neighborhood Electric Vehicle (NEV).

In lieu of replacing Truck 17 (One Ton Truck), we have solicited quotes for a NEV. These vehicles run on battery power only, have a maximum speed of 25 mph, and would be used (generally) for our seasonal employees in doing shelter maintenance, trimming, and general park tasks around the City. We were unable to receive the quotes prior to the Park Board packets going out, however I will provide you with a packet and recommendation at the meeting.

Staff Recommendation: None at this time.

#### 10. Review and consider acquisition of wide area mower.

We have received four quotes with regard to the purchase of a new wide area mower. Due to some bid variations, we were unable to make a recommendation prior to this packet going out. A meeting of the Board of Park Commissioners was held on Thursday, January 15, 2009 at 6:30 pm at the De Pere Ice Center, Conference Room, 1450 Fort Howard Avenue, De Pere. Prior to the meeting, members of the Park Board were given a tour of the facility by Kelly Sperl and Carl Magnuson. Members present: Citizen Members: George Brown, Sue Schinkten, Absent, Bill Volpano, Rod Kowalczyk. Alderpersons Van Vonderen, Donovan and Boyd. Also present: Marty Kosobucki, Director.

   Mike Donovan moved to approve the minutes; motion seconded by Sue Schinkten. Motion passed.
- Approve out-of-state training for Director of Parks, Recreation and Forestry.
   Kathy Van Vonderen moved to approve the minutes; motion seconded by James Boyd. Motion passed.
- 3. General discussion related to De Pere Ice Arena.

Marty Kosobucki explained to the Board that by December 2009, the City must notify Ice Time Management of their plans for the Ice Center. The current contract expires in December 2010. Marty explained that the goal for this meeting was to have an open forum to learn more from the user groups and to see the components of the Ice Center. Mike Donovan moved to open the meeting to the public (6:42 pm); motion seconded by Kathy Van Vonderen. Motion passed. Dan Reynolds, De Pere Youth Hockey, Vicki Saks, Greater Green Bay Figure Skating, A.J. from St. Norbert JV Hockey, and Carl Magnuson, Deacons were in attendance for the meeting to give their input on their respective groups. Also present were Dave Lepp, Manager, Ice Time Management, Chris Van Hoof, Office Manager, as well as Kelly Sperl, Carl and Diane Magnuson, Ice Time Management, Inc.

A.J. St. Norbert College JV Hockey, briefly updated the Park Board members that SNC JV Hockey is not going anywhere. Will be staying at the De Pere Ice Center. They have games at this facility as well as road games. Program runs from September through December. Roster has 25 skaters, 3 goalies.

<u>Dan Reynolds</u>, <u>De Pere Youth Hockey</u> has 235- 240 members, ranging from very young children to high school age. The High School has its own ice program. Reynolds explained the mini mites and mites' numbers are growing. The High School team is a no-cut system, where you have varsity, junior varsity. Reynolds threw out the idea of having a dry land cage as a practice facility and De Pere Youth Hockey would possibly help fund the project. This type of cage would help build endurance for the players. Reynolds will research this further and get the information to Marty Kosobucki for Board review.

<u>Vicki Saks</u>, <u>Greater G.B. Figure Skating</u>, stated they contract 20-25 hours per week for ice time. The "Learn to Skate Program" has 121 members; and the 3 synchro teams have 135 members. They hold competition in the summer months, ages 5 to adults, with 100 members overall. Vicki mentioned that the bleachers pose a safety issue, especially for the elderly people. When they have competition, she mentioned a larger judges' area is needed, along with computer access. She feels the fees charged for ice rental are very reasonable and affordable.

The Mayor asked the question what does Ice Time Management see for the future?

James Boyd was excused at 7:50 pm from the meeting.

After further discussion, the Board requested the User Group representatives go back to their respective group and discuss their future, i.e, what are the projected future numbers for the groups, along with future forecasting and what improvements they would like to see at the Ice Center. This information will be given to the Park Board and the City for review.

Kathy Van Vonderen moved to go back to regular session (7:55 pm) with a second to the motion being made by Mike Donovan. Motion passed.

#### 4. 4th Quarter Report from Community Center. (Handout).

Kathy Van Vonderen moved to approve and place report on file. Motion seconded by Mike Donovan. Motion passed.

#### 5. 4<sup>th</sup> Quarter Report and Annual Report from Ice Center. (Attachments)

Kathy Van Vonderen moved to approve and place report on file, seconded by Mike Donovan. Discussion: Marty Kosobucki explained the Ice Center contract states that each quarter the City is to be paid \$7,500 for the lease. In addition, at the end of the year (December) the contract states a percentage of net income be put into a designated fund that rolls over each year. This fund is then used for major projects at the Ice Center, such as the dehumidification project. George Brown commented that the Directors Fee listed on the profit and loss statement be changed due. When you see Directors Fee it appears that an individual is being paid, where in fact, it is the fee being paid to the City for the Ice Center Designated Fund. George Brown also suggested that the date for the new lease not end in the month of December, since this is in the middle of the Ice Center's season, and further suggested lease termination be in the middle of summer. Motion passed.

#### 6. Public Comment Period. None.

#### 7. Future Agenda Items.

On the February Park Board agenda, we will be discussing the sponsor moneys given to the user groups each year.

# Commission on Aging

A meeting of the Commission on Aging was held on January 22, 2009 at the De Pere Community Center. Members attending were Al De Cleene, Jim De France, Carol Peters, and Millie Bain. Also present: Lori Pazdera, Senior Program Coordinator and Paula Rahn, Community Center Manager. Excused Absent: Rachel Dickhut

- Approval of minutes of the November 20, 2008 meeting. Attachment.
   Motion to approve the minutes was made by Millie Bain. Jim De France seconded the motion. Motion carried.
- 2. Review findings of other centers and how they provide snacks to card clubs. Senior Program Coordinator, Lori Pazdera shared information obtained from neighboring municipalities in regards to luncheon offerings at their sites during senior programs. Ashwaubenon, Bellevue and Allouez provides either paid staff or volunteers to run the luncheon at their sites. They are responsible for shopping, setting up, collecting payment during, and maintaining the program. A 50 cent charge to all participants is collected prior to the card playing. At this time, the commission agrees in order for this program to run properly, we would need a volunteer to supervise the program as staff would not be available on a consistent basis. The January 27th kickoff has been postponed to Tuesday, February 10th. Center staff will inform participant that a small lunch will be provide at minimal cost on that date. Millie Bain and Carol Peters of the Commission Committee have agreed to bake some cookies and help set this one time offering. We will then review the popularity and need following the February 10th date as to whether or not we will continue with the offering.

#### 3. Volunteer Issues.

The senior bingo program continues to deal with constant friction and personality issues among the volunteers and the bingo caller. In the past year Senior Program Coordinator, Lori Pazdera, has met with the Bingo volunteers to discuss and attempt to resolve the problems within this group. A group of participants have brought it to the attention of Lori that the Bingo caller has been showing anger at some and "favoritism" towards others. They have asked for a new bingo caller. While personalities are very tough to deal with, Lori explained to them they need to find a bingo caller that will be consistent to replace the current bingo caller as he has been a regular caller for almost a year.

Also discussed at the meeting was that volunteers must sign in each time they volunteer, what job duty they are providing, and hours they worked, to ensure accountability. Job duties such as set up, take down and clean up are responsibilities of the volunteers and must be done every time they sign on as a volunteer. Volunteers were also reminded that they must be an active volunteer in order to be invited to the Christmas party.

Lori is currently working on establishing criteria for volunteers and basic job responsibilities. At this time, other volunteers assist with Sheepshead, Bridge, Cribbage and Duplicate Bridge and will also be reminded to sign in regularly to stay consistent with the overall direction of the volunteer program.



Teen Advisory Position

- The teen advisory seats on the Park Board shall be open to persons of high school age who reside in the City of De Pere.

- Applications shall be on a form supplied by the Director and shall be submitted to the Director on or before May 1 of each year. The Director shall review all submissions and may interview those persons whom the Director deems qualified and shall make recommendation to the Mayor of De Pere on whom to appoint to the teen advisory seats.
- The Board of Park Commissioners holds a regular scheduled meeting on the third Thursday of the month and starts at 6:30 pm.
- An agenda and packet of support information is sent to all board members prior to the meeting. Board members are expected to view the material prior to the meeting.
- The Teen Advisory Position is a participating member of the committee, however does not have a legal vote.
- Each Teen Board member is attempted to be paired with a current board member to serve as a guide or mentor.

### **User Group Funding**

Summary: The Park Board has been asked by the City Council to review and consider funding options and cuts to the local youth user groups for the 2010 year and beyond. A total of \$32,000 in funding is provided to several groups based in De Pere that focus on youth athletic programming. I have provided one table that describes the user groups, funds allocated to them in 2008, and other additional info that may be beneficial to consider. I have also provided a second table that shows you a historical perspective in relation to participant numbers in each of the youth programs. The Park Board has a very unenviable task of considering cuts to each of the programs. I have invited all of the user groups to attend this meeting to provide feedback. I would like to state that for the amount of money given to the user groups compared to the amount of impact provided for youth in our community, our donation to the user groups is a very worthwhile investment.

#### Recommendations:

- 1) Leave 2009 allocations the same and do not change.
- 2) I do not believe the Park Board should make any decisions at this particular meeting related to funding for 2010 and beyond. First, I believe the Park Board should hear from each of the user groups on what impact the money has on their efforts and programming for youth.
- 3) Have staff develop a funding proposal or reduction in funding proposal and bring back to the March Park Board meeting. It is encouraged to have a couple of the Park Board members work with staff in developing the proposal.
- 4) After the Park Board approves the proposal, it should be sent to the City Council for consideration.

Mandated Swimming Pool Standards

The federal law called the Virginia Graeme Baker Act, was enacted for public swim pools and spas. A pool company must be hired to review our circulation systems, replace some of our drain grates and possibly do other related work to some of our drains. We are required to protect against entrapment and entanglement at Legion and VFW swim pools. All items must be completed prior to when we open on June 13.

I contacted four companies from around the state that were qualified to do this work. Only two of these companies, Pool Works and Ramaker, submitted proposals. These two with their prices are as follows.

Pool Works \$3080 Ramaker \$7000

Additional work may be needed to modify our six drains in the main pools. Ramaker doesn't do this work. Pool Works can do this; the cost for this, if needed, would be \$3000. Therefore, I recommend that the City select the low proposal from Pool Works, not to exceed \$6080.

We did not budget any money for this expense, as we were unaware of what would be needed to comply with this law. Please feel free to contact me if you have any comments regarding this matter.


