BOARD OF PUBLIC WORKS

A regular meeting of the Board of Public Works was held on Monday, May 10, 2010, at 7:30 pm in the Council Chambers at City Hall.

1. Roll Call

Members present on roll call: Mayor Walsh, Alderperson's Wilmet, Boyd, Heuvelmans and Bauer. Members absent on roll call: None.

Others present: Scott Thoresen - Director of Public Works, Sue Selissen - Public Works Secretary, recording secretary.

2. Approve minutes of the regular meeting held on April 12, 2010; which were previously forwarded to Board Members

Minutes of the April 12, 2010 regular meeting previously forwarded to members of the Board were presented. A motion to approve the minutes was made by Alderperson Heuvelmans, seconded by Alderperson Wilmet. Upon vote, motion was carried unanimously.

3. Discuss 65-Gallon Garbage Carts

Scott Thoresen, Public Works Director, presented this agenda item to the Board that was previously discussed at last months meeting. He stated that he had discussed this item with staff again and it was recommended that to promote recycling, we charge \$25 for a small garbage cart and \$90 for a large one. At this time, the costs of recycling carts will remain the same. Alderperson Bauer asked if there were any plans for educating the residents on recycling. Scott stated that he is working on a video that shows the recycling process, addresses the savings of tax dollars and also educates residents on cart storage at the home and other information pertaining to collection. Alderperson Boyd asked if a resident could swap a large cart for a small cart at no additional cost. Scott reiterated that this new policy would basically affect residents who are purchasing new carts due to new home construction and added that a resident could certainly swap if they wanted to. A motion to approve the new price schedule for garbage carts was made by Alderperson Boyd with the condition that a resident could swap a large cart for a small cart at no additional charge, seconded by Alderperson Wilmet. Upon vote, motion was carried with 4 Ayes (Mayor Walsh, Alderpersons Wilmet, Boyd and Bauer) and 1 Nay (Alderperson Heuvelmans).

4. Discuss MSC Rubbish Drop Off Policy

Scott Thoresen, Public Works Director, presented this agenda item to the Board that was previously discussed at last months meeting. Scott stated that after several residents that reside next to the MSC expressed a concern about drop off occurring at night, staff reviewed the policy and is now recommending that drop off hours be limited to the hours of 7am – 7pm, 7 days a week under camera surveillance, adding that this new drop off policy will be re-evaluated after one year. Scott also stated that if approved, the purchase of the new camera will be presented to the Common Council on May 18th. After a brief discussion, a motion was made to approve the purchase of the camera and to change the drop off hours from 7am – 7pm by Alderperson Heuvelmans, seconded by Alderperson Boyd. Upon

vote, motion carried with 4 Ayes (Mayor Walsh, Alderpersons Heuvelmans, Wilmet and Boyd) and 1 Nay (Alderperson Bauer).

5. Elect Vice Chairperson

After a brief discussion, a motion was made to elect Alderperson Heuvelmans Vice Chair by Alderperson Wilmet, seconded by Alderperson Boyd. A motion was made to elect Alderperson Boyd for Vice Chair by Alderperson Heuvelmans, seconded by Alderperson Bauer. Upon vote, the motion to elect Alderperson Heuvelmans was carried with 3 Ayes (Mayor Walsh, Alderperson Wilmet and Boyd. Alderperson Boyd received votes from Alderperson Heuvelmans and Bauer.

6. Approve Bid for Project 10-02, Brick Paver Maintenance and Concrete Sealing

After a brief discussion a motion was made to approve the bid from A&M Concrete and Construction, Inc. in the amount of \$38,511.00 by Alderperson Wilmet, seconded by Mayor Walsh. Upon vote, motion carried unanimously.

7. Approve Bid for Project 10-04 Street Construction and Reconstruction

With no discussion, a motion was made by Alderperson Boyd to approve the bid from Peters Concrete Company in the amount of \$401,771.67, seconded by Alderperson Bauer. Upon vote, motion carried unanimously.

8. Approve Bid for Project 10-05 Sidewalk and Concrete Repairs

After a brief discussion regarding notification of residents and information about contracting out their work vs. it being completed by the City, a motion was made by Mayor Walsh to approve the bid from Fischer-Ulman Construction, Inc. in the amount of \$156,292.00, seconded by Alderperson Wilmet. Upon vote, motion carried unanimously.


Purchase of Trench Box

The Occupational Safety and Health Administration (OSHA) requires a protective system such as trench boxes when the water department excavates for water main or water lateral repairs. (See attached OSHA trenching and excavation safety fact sheet) The water department has a larger trench box used for excavating for water main repairs but is in need of a smaller trench box for performing water lateral repairs.

Staff has obtained three (3) quotes for the purchase of a trench box for water lateral repair.

MMJ Consulting Allen Trench Shoring = \$7,453.00 Safety Corporation of America = \$7,682.00 J&B Tool Inc. = \$7,798.00

It is recommended that the City purchase the trench box from MMJ Consulting Allen Trench Shoring in the amount of \$7,453.00. This item was not originally budgeted as part of the 2010 budget. Therefore, staff recommends funding for this purchase is taken from the capital account of the water utility.

Trenching and Excavation Safety

Excavation and trenching are among the most hazardous construction operations. OSHA defines an excavation as any man-made cut, cavity, trench, or depression in the earth's surface formed by earth removal. A trench is defined as a narrow underground excavation that is deeper than it is wide, and is no wider than 15 feet (4.5 meters).

Dangers of Trenching and Excavation

Cave-ins pose the greatest risk and are much more likely than other excavation related accidents to result in worker fatalities. Other potential hazards include falls, falling loads, hazardous atmospheres, and incidents involving mobile equipment. Trench collapses cause dozens of fatalities and hundreds of injuries each year.

Protect Yourself

OSHA Home

Do not enter an unprotected trench! Trenches 5 feet (1.5 meters) deep or greater require a protective system unless the excavation is made entirely in stable rock. Trenches 20 feet (6.1 meters) deep or greater require that the protective system be de-signed by a registered professional engineer or be based on tabulated data prepared and/or approved by a registered professional engineer.

Protective Systems

There are different types of protective systems. Sloping involves cutting back the trench wall at an angle inclined away from the excavation. Shoring requires installing aluminum hydraulic or other types of supports to prevent soil movement and caveins. Shielding protects workers by using trench boxes or other types of supports to prevent soll cave-ins. Designing a protective system can be complex because you must consider many factors: soil classification, depth of cut, water content of soil, changes due to weather or climate, surcharge loads (eg., spoil, other materials to be used in the trench) and other operations in the vicinity.

Competent Person

OSHA standards require that trenches be inspected daily and as conditions change by a competent person prior to worker entry to ensure elimination of excavation hazards. A competent person is an individual who is capable of identifying existing and predictable hazards or working conditions that are hazardous, unsanitary, or dangerous to employees and who is authorized to take prompt corrective measures to eliminate or control these hazards and conditions.

OSHA requires safe access and egress to all excavations, including ladders, steps, ramps, or other safe means of exit for employees working in trench excavations 4 feet (1.22 meters) or deeper. These devices must be located within 25 feet (7.6 meters) of all workers.

General Trenching and Excavation Rules

- Keep heavy equipment away from trench edges.
- Keep surcharge loads at least 2 feet (0.6 meters) from trench edges.
- Know where underground utilities are located.
- Test for low oxygen, hazardous fumes and toxic gases.
- Inspect trenches at the start of each shift.
- Inspect trenches following a rainstorm.
- Do not work under raised loads.

Terrace Tree Impacts to Sidewalk

The City has an annual sidewalk inspection program where the sidewalk is inspected for being defective and repairs are ordered out to the adjacent property owners. The sidewalk repair and replacement program is broken out so that 1/8 of the City is done each year. (See attached sheet)

One impact to sidewalk are trees that are adjacent to sidewalk especially the terrace trees. I have attached a summary of the past six (6) years of sidewalks that needed repairs due to terrace trees. The tree impacts range from 14 in 2008 up to 64 in 2007. Repairs to damage sidewalk caused by terrace trees are normally remove and replace existing sidewalk or by mud jacking the existing sidewalk. Staff has experience that approximately 1/3 of these repairs can be done with mud jacking and the other 2/3 need to be removed and replaced. Staff has also experienced that normally 70% of the repairs done adjacent to trees will still be adequate 8 years later when the City inspects the sidewalk again. The average costs for mud jacking is \$60 per tree impact and the costs for removal and replacement of the sidewalk is \$240 per tree impact. These costs are based on the City's contractor performing the work.

Staff has recently discussed this issue in great length due to the fact more and more residents are requesting that the terrace trees be removed because they do not want to have to fix the sidewalk and have the trees cause damage again. Staff feels very strongly that the terrace trees are a huge benefit (see attached information pertaining to the value and importance of trees) to the community and adjacent property owner and should not be removed because of damage to the sidewalk. Since the terrace trees are owned by the City staff and the City requires sidewalk, staff is recommending a policy where if the sidewalk adjacent to a terrace tree needs to be repaired that the City would pay for such repairs. This would mean the City would have to budget additional monies every year to implement this policy. Staff estimates this would cost the City approximately \$6,000 additionally every year. If the BOPW approved this policy and wanted to implement this policy starting this year then additional monies would have to be bonded for in 2010.

It is recommended that the BOPW adopt a sidewalk repair policy where the City would pay for all costs to repair sidewalks damage by terrace trees. The City would budget monies annually for these repairs. The policy should be implemented in 2010 and additional monies would be bonded for in 2010 to cover these costs.





What is "the urban forest"?



Trees that grow in cities and towns are called "the urban forest". Trees are major capital assets in cities across the United States. Just as streets, sidewalks, public buildings and recreational facilities are a part of a community's infrastructure, so are publicly owned trees. Trees -- and, collectively, the urban forest -- are important assets that require care and maintenance the same as other public property. Trees are on the job 24 hours every day working for all of us to improve our environment and quality of life. Life is hard for these trees because of limited space, water, nutrients and extensive pavement covering the soil all around them. Many trees get cut down because their roots crack the

pavement as they seek water and nutrients. The urban forest (and its many benefits) will disappear unless people stand up for these trees and work to plant, maintain and steward them. Conscious urban forestry needs to become integrated into the agenda of all city governments and city planners.

What is the value of a tree?

A tree can return up to \$2.70 for each \$1 on community investment...that's a 270% return (based on a 40 year average life span according to Center for Urban Forest Research, Pacific Southwest Research Station, U.S. Forest Service, Davis, CA)

- Four trees planted around a home can save up to 30% on summer cooling costs.
- One million trees save \$10 million a year in energy costs.
- Forty trees remove 80 pounds of air pollutants annually.



Case studies on trees and the bottom line

The primary purpose of a study Quantifying Benefits and Costs of Santa Monica's Urban Forest was to find out if the accrued benefits from Santa Monica's urban forest justify an annual municipal budget that exceeds \$1.5 million. Results indicate that the benefits residents obtain from Santa Monica's urban forest exceed management costs by nearly \$1 million. Santa Monica has invested millions of dollars in its municipal forest, and citizens are now receiving a relatively large return on that investment, such as increased property values, enhanced scenic beauty, air pollutant uptake, cooling and heating savings, lower summertime temperatures, and reduced stormwater retention.

A study of urban forests in Modesto, CA shows that for each \$1 invested in urban forest management, \$1.89 in benefits is returned to residents. City trees actually remove 154 tons of air pollutants, increase property values by over \$1.5 million, and provide shade that saves over \$1 million. This information convinced city officials to increase the tree budget and an electric utility company to invest \$20,000 in developing the Modesto Tree Foundation.

In Milwaukee, where urban trees cover about 16 per cent of the city, trees reduce stormwater flows by 22 per cent. The city saves an estimated \$15.4 million by avoiding the construction of additional retention capacity. In Austin, heavy rains make stormwater management a priority issue. Austin's tree canopy, almost twice that of Milwaukee's at approximately 30 per cent, reduced stormwater flow by 28 per cent, providing the city with an estimated \$122 million in savings (MacDonald, 1996).

Several investigators have documented dramatic (30 - 50%) differences in cooling–energy use between houses on landscaped and un-landscaped sites (Akbari, 2002).

Hurricane Hugo devastated Charleston, South Carolina, in 1989. Little was spared: homes, churches, power lines, and the urban forest were all heavily damaged or destroyed. 200 residents were asked to identify the single most special physical feature of Charleston damaged or destroyed by Hugo. People identified the urban forest more often than any other aspect of Charleston (i.e. more than churches, historic buildings or homes) (Vigo, 1990).


Computer simulations using standard building and tree configurations for cities across the U.S. indicate that shade from a single well-placed, mature tree (about 25-ft crown diameter) reduces annual air conditioning use 2 to 8 percent and peak cooling demand 2 to 10 percent (Simpson and McPherson, 1996).

A major study of Chicago estimated that trees in that city annually removed 15 metric tons of carbon monoxide, 84 tons of sulfur dioxide, 89 tons of nitrogen dioxide, 191 tons of ozone, and 212 tons of small particulates. The estimated value of this pollution removal was \$1 million for trees in the city itself and \$9.2 million for the entire Chicago area (Nowak, 1994).

The ambient air temperature difference between an urban heat island and a vegetated area can be as much as 2-10 degrees F. The temperature measured directly above man-made surfaces can be as much as 25 degrees F hotter than the air temperature beneath a forested area (Akbari et. al., 1992; Simpson and McPherson, 1996).

Using the city of Davis, California as a model, existing data on the benefits and costs of municipal trees were applied to the results of a sample inventory of the city's public and private street trees. Results indicate that Davis maintained nearly 24,000 public street trees that provided \$1.2 million in net annual environmental and property value benefits, with a benefit-cost ratio of 3.8:1 (Maco and McPherson, 2003).

The planting of trees means improved water quality, resulting in less runoff and erosion. This allows more recharging of the ground water supply. Wooded areas help prevent the transport of sediment and chemicals into streams. -USDA Forest Service

In laboratory research, visual exposure to settings with trees has produced significant recovery from stress within five minutes, as indicated by changes in blood pressure and muscle tension. -Dr. Roger S. Ulrich Texas A&M University

A tree can grow to manufacture five pounds of pure oxygen per day, consume carbon dioxide to fight the "greenhouse effect" that threatens our survival, and provide the cooling equivalent of ten room-size air conditioning units.



What are trees worth?

The value of tree benefits varies widely, but can be as much as \$80 to \$120 per tree per year for a large tree. Small trees that never get very large, like the crape myrtle, provide not much more than \$15 in benefits on average. In some cases they are a net loss to communities after the costs are subtracted. The Center for Urban Forest Research has studied large, medium, and small trees in a number of locations throughout the West and found that, on average, mature large trees deliver an annual net benefit two to six times greater than mature small trees:

Economic Contributions

- · Research shows that shoppers in welllandscaped business districts are willing to pay more for parking and up to 12% more for goods and services.

Environmental Contributions

- Modest increases of 10% canopy cover in the New York City area were shown to reduce peak ozone levels by up to 4 parts per billion or by nearly 3% of the maximum and 37% of the amount by which the area exceeded its air quality standard. Similar results were found in Los Angeles and along the East Coast from Baltimore to Boston.*



Tri-County Single-Stream Recycling Facility



The brand spanking new Tri-County Single-

Stream Recycling (TCSSR) facility, located in Appleton, Wisconsin, is a byproduct of the newly-combined recycling programs of Brown, Outagamie and Winnebago counties. The largest public-sector single-stream MRF in the Badger State and one of the larger publicly owned and operated single-stream plants in the U.S., the TCSSR presently serves some 60 communities (over 200,000 households) within the three counties, handling both residential and commercial recyclables.

"We have brought a new era of recycling to Wisconsin," says Philip Stecker, Outagamie County's director of solid waste. "This facility allows us to serve some 500,000 residents in Northeastern Wisconsin; that's 10 percent of the state's total population."

Operated by Outagamie County, the \$9.9 million regional facility includes a state-of-the-art single-stream processing system designed, engineered, manufactured and installed by Bulk Handling Systems. Outfitted with the latest in screening, optical and

air-separation technologies, the system was created by BHS to process an average of 25 tons per hour, all while generating minimal residual

According to company representatives, the single-stream system employs the use of integrated processes that emphasize mechanization, and the extraction of recoverable materials, all on the first pass. As a result, this technology allows the TCSSR to experience a high-value material capture rate of nearly 100 percent, and produce an end-product with extremely low residue values (projected to be less than three percent). In addition to including a large old corrugated cardboard separator and steel disc debris roll screen, in order to remove virtually all glass at the front end (currently, glass content is approximately 25 percent of the overall material flow), the processing system also includes a unique filtration system that provides a cleaner, dust-free working environment for the plant's 20 total employees.

The system's main sorting stations include presort, paper post-sort and container sort, with three other smaller sorting stations located



This is in response to your concerns whether USCI will perform the same scope of work as Dixon.

YES, USCI does very similar tank assessments, and we will include all of what is listed in Dixon's scope

USCI does use a high pressure power washer to clean the interior wet surface. Any sediment and debris will be removed to the ground. As I mentioned when you and I met, if you have a truck available, we will place as much of the sediment in the truck as possible along with any other debris removed from the tank, (ie.spent cathodic rods, wood, leaves, paint chips, other metal debris, dead birds, etc.).

USCI will assess the interior wet coating system for any failures, an adhesion test will be completed, and coating samples will be taken to determine the generic make up and then will be tested for heavy metals

USCI will assess the tank's interior for any structural defects, damage done from icing, and corrosion.

The wind and riser rods will be assessed for damage and proper tightness.

The foundations, grout, and caulk will be assessed for any damage.

JSCI will assess all of the ladders and safety equipment for damage, corrosion, and safety climbs for

JSCI will assess the tank for all sanitary concerns, i.e. for possible contamination and its entry point.

Traffic:

1. Merrill and Broadway Intersection.

The group was asked to analyze the intersection for safety. For the short term, the committee recommended that Public Works confirm the timing and sequencing of the movements to ensure pedestrian safety. The intersection will also be improved this year with an additional crossing that will be added to the north side of Merrill. The committee also recommended that the intersection should have 'crosswalk countdown signs' added.

Signage:

2. West Wood Elementary.

A request was made by West Wood Elementary to improve the on street parking. The police liaison officers' made some suggestions to change the parking. These concepts were going to be research by Public Works and then some follow up meeting would be schedule between the City and the West De Pere School District.

3. Handicap Parking request.

A request was made to add handicap parking in the James Street stalls across from the Union Hotel. Staff reviewed the request and determined it can not be done given the design of the lot. The slope and existing ROW limit the ability to add legal stalls.

4. Signage on Main and Reid.

A request was made to add signage to Main and Reid warning drivers of stopped traffic. This item was referred to the Police department to check on traffic warrants and to see how sign could be added if considered.

5. Traffic Control at Desplaine and Charles.

The street department completed a traffic study in March. The study did show some speeding; however the majority of the traffic was within limits. Police had also checked for supporting traffic warrants; however there were none found.
