Health Information

Water from our three wells is blended periodically into the distribution system to keep it fresh. We purchase 787,671,000 gallons of water from the Manitowoc Public Utility in 2013. We blended 603,000 gallons of water from our three wells with water treated surface water from Manitowoc Public Utility. This is 0.2 percent groundwater.

Educational Information

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants such as salts and metals, which can be naturally- occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

AL	Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Additional Health Information

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. De Pere Water Department is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. Information on Monitoring for Cryptosporidium and Radon

Our water system did not monitor our water for cryptosporidium or radon during 2013. We are not required by State or Federal drinking water regulations to do so.

Turbidity Monitoring

In accordance with s. NR 810.29, Wisconsin Administrative Code, the treated surface water is monitored for turbidity to confirm that the filtered water is less than 0.1 NTU/0.3NTU. Turbidity is a measure of the cloudiness of water. We monitor for it because it is a good indicator of the effectiveness of our filtration system. During the year, the highest single entry point turbidity measurement was 0.09 NTU.

System News

During 2013, the City continued our replacement of older water lines focusing on those in areas where we will be reconstructing roads or are experiencing excessive water main breaks. The areas where water main were replaced included: Bolles Street from S. Superior Street to S. Erie Street; Foxview Avenue from Fort Howard Avenue to end; Mansion Street from S. Erie Street to Jordan Road; S. Michigan Street from Bolles Street to Merrill Street; Prospect Place from Lost Dauphin to end; River Avenue from 500 feet East of Fort Howard to end; Riverview Avenue from Third Street to End. The City also installed new water main that included: Roth Road from 200 feet east of Ryan Road to Killarney Trail; Ballinamore Place from Kilrush Road to Tullig Place; Tullig Place from Galway Lane to Ballinamore Place. The City also continued with its annual hydrant replacement and City wide cross connection inspection programs.

In 2013 the City also performed a City wide leak detection survey on the water distribution system. 45 leaks were found in the system and were repaired.

In 2014, work will focus on water main replacements along: Lilac Lane from Fourth Street to the railroad tracks; Belle Avenue from Lost Dauphin Road to the Fox River; Butler Street from Sixth Street to the West De Pere High School; Seventh Street from Westwood Drive to Helena Avenue; Lawton Place from Ridgeway to 300 feet North of Randall Street; Morning Glory Lane from Apollo Way to Allard Street; Twilight Drive from Morning Glory Lane to Park Street; Sunnyview Avenue from Twilight Drive to Sunrise Court; South Michigan Street from Merrill Street to George Street. The City will also be installing new water main on County Highway PP from Prosper Street to Viking Lane.

In 2014 the City will also be doing the following work: repainting hydrants City wide, 9th Street well maintenance and repairs; Scheuring Road well maintenance and repairs; Scheuring Road reservoir cleaning and painting; Merrill Tower cleaning.

In 2014 the City will continue with the residential, commercial, and industrial cross connection inspection program being conducted by Hydro Designs.

In 2014, the City will begin implementing and installing automated meter reading system.
