## **General Information**

Players will be notified of their first scheduled match by 4:00pm on Friday, July 20th.

Matches will be scheduled during the morning, afternoon and early evenings at De Pere High School (1700 Chicago Street, De Pere). Entrants will be given a ten-minute grace period, before a scheduled match is considered a forfeit.

The Tournament Director will determine pairings and matchups.

This is a single elimination tournament. Winners of all age categories must win 2 of 3, 6 game sets. No-Ad scoring will be used for any games. 12-point tiebreakers will be used if necessary. Players are to call their opponent's shots. Each player has an ethical obligation to follow all rules. Refunds will only be issued if the tournament is cancelled by the Tournament Director.

In case of inclement weather, entrants should call the Parks, Recreation and Forestry Department for re-scheduling information. If a match is cancelled due to inclement weather, play will start the following day, and Wednesday, July 25th is scheduled as a weather make-up day, if needed.

All participants will receive t-shirts, and the division champions will receive trophies.

This is a non-sanctioned, open tournament.
