

The purpose of this addendum is to correct bid quantities and replace the bid schedule.

CHANGES TO THE PROJECT BID DOCUMENTS IN ADDENDUM NO. 4:

- 1. Delete Section 00 41 43, Bid Schedule and replace with section 00 41 43R, Bid Schedule. Changes to the bid schedule include::
 - a. Correction in Bid Quantity for Item SD-06 Pulverize Asphaltic Concrete Pavement and Aggregate (8-inch depth) and remove top 3-¾ inches of material (Patriot Way). Square yardage was reduced from 8,300 to 920.
 - b. Correction in Bid Quantity for Item SD-13 Provide Asphaltic Concrete Pavement Type 4 LT 58-28S 1-¾ inch Upper Layer. Tonnage was reduced from 5,000 to 4,800.
 - c. Correction in Bid Quantity for Item SD-17 Provide Asphaltic Concrete Pavement Type 3 LT 58-28S 2-¼ inch Lower Layer. Tonnage was reduced from 2,600 to 1,900.
