CITY HALL WINDOW REPLACEMENT REBID

Online bids will be received and accepted for Project 22-17 City Hall Window Replacement Rebid via the online electronic bidding service through QuestCDN.com, until 1:00 PM, Thursday, June 2, 2022, at which time they will be publicly accepted, displayed and read aloud.

Project 22-17 Rebid for which proposals are being sought includes the following approximate quantities:

- First and Second Floor Storefront and Window Replacements
 - 1 each 6W x 2H – 232" x 112" frame with one 3' x 7' door (storefront)
 - 1 each 6W x 1H – 232" x 103" (storefront)
 - 25 each 1W x 2H – 24" x 96" windows
 - 25 each Internal blinds at top and bottom lites of 1W x 2H 24" x 96" windows
- Main Entrance Glass Replacement
 - 1 each 47 ¼" x 91 ¼" grey Low-E tempered
 - 1 each 15 ¼" x 91 ¼" grey Low-E tempered
 - 2 each 28 ¼" x 72 ¾" grey Low-E tempered

Digital plan documents may be downloaded for \$15 by inputting Quest project #8202397 on Quest's Project Search page. Project documents must be downloaded from QuestCDN which will add your company to the Planholder List and allow access to vBid online bidding for the submittal of your bid. Bidders will be charged an additional fee of \$30 to submit a bid electronically. Each proposal shall be accompanied by a bid bond in an amount equal to five percent (5%) of the bid, payable to the City of De Pere, as a guarantee that if the bid is accepted, the bidder will execute a contract and furnish a contract bond as set forth in the General Conditions of the City of De Pere. In case the bidder fails to file such contract and bond, the amount of the bid bond shall be forfeited to the City of De Pere as liquidated damages.
