A meeting of the Board of Park Commissioners was held on Thursday, August 20, 2009 at 6:30 at the Municipal Service Center, 925 S. Sixth Street, De Pere. Members of the Park Board present: Kathy Van Vonderen, Mike Donovan, Sue Schinkten, James Boyd, George Brown, Rod Kowalczyk and Bill Volpano. Also present: Marty Kosobucki, Don Melichar. Ernie Christus, Paula Rahn. In addition, Maddie Chitwood and Kathy McGurk, Teen Advisory Representatives.

   Mike Donovan moved to approve the minutes, seconded by James Boyd. Motion passed.

- 3. 2<sup>nd</sup> quarter report from Community Center. (Attachment)
  George Brown commented that under Paula Rahn's leadership, it appears the Community Center is proving to be an excellent resource to citizens, of all ages, of De Pere, and is a real asset to the City. Paula and her staff are to be commended. Kathy Van Vonderen moved to receive and place on file, seconded by Bill Volpano. Motion passed.

He then sent two emails and received some information stating they haven't been able to discuss this issue at present. At this point the City is not taking any different approach until Ledgeview gets back to us. George Brown moved to have Staff continue to work with Ledgeview and recommended that a year-to-year agreement would be best. Staff will bring any new information to the Board. George Brown also encouraged that Marty request RMS to include a final presentation to the Board, in-person would be the best method, tele-conference would be the next best option. - c. Park and Recreation Transition The staff is working cooperatively undertaking the programs that will be running when Ernie retires. An ad was placed with the WPRA and as of today, 61 applications had been filed. The deadline is September 2.

  - <u>Dog Park</u> Don Melichar was informed that the City received 4,000 linear feet of used fencing from Outagamie County Airport. Don estimates the fencing could go up yet this fall or spring, 2010, depending on donations to purchase posts, etc.
  - <u>Riverwalk Project:</u> Marty updated the Board that this project has been put into high gear. DNR has approved the project and we need to complete a different permit for them. Grant money has been approved for this project and these funds must be used within a 2-year timeframe.


